## 12 NCAA Championships Scheduled in Next Month

The National Collegiate Athletic Association moves into its busiest period of the year early in March, with 12 National Championship events on the schedule within a four week period. Over 2500 athletes will be competing.

The National Collegiate Basketball Championship annually attracts the most attention, but other sports also will be getting their annual place in the spotlight.

The University Basketball Tournament will be played at four regional sites on March 12 and 14, then will move to College Park, where the University of Maryland will host the finals tournament.

The College Division Tournament starts with eight regionals and a 32-team field on March 6-7, then moves to Evansville, Ind., for the Championship, with the eight regional winners beginning finals play on March 11, and battling for the title on March 13.

The University of Evansville hosts the Championship at Roberts Memorial Stadium.

The National Collegiate Swimming Championships should provide fans in Salt Lake City the opportunity to watch probably the finest competition in the 48-year history of this event.

### Indiana Favored

Indiana will be heavily favored to win its third straight team crown, but the individual races should produce exceptional times, with many defending champions returning, and some who were champions in 1968 returning after sitting out last season following Olympic competition.

The University of Utah will be the host, March 26-28.

The other National Collegiate Championships to be contested within the period are:

**Fencing**, hosted by Notre Dame, South Bend, Ind., March 19-21; **Gymnastics and Trampoline**, hosted by Temple University, Philadelphia, Pa., April 2-4; **Skiing**, hosted by Dartmouth, Franconia, N. H., March 5-7; **Indoor track**, hosted by the University of Michigan, Cobo Hall, Detroit, Mich., March 13-14; **Ice hockey**, hosted by St. Lawrence University, Lake Placid, N. Y., March 19-21; **Wrestling**, hosted by Northwestern, Evanston, Ill., March 26-28.

College Division Championships are: **Gymnastics**, hosted by Mankato State College, Mankato, Minn., March 26-28; **Swimming**, hosted by Oakland University, Rochester, Mich., March 19-21 and **Wrestling**, hosted by Ashland College, Ashland, Ohio, March 13-14.

## Council to Meet In Fla. in April

The spring meetings of the NCAA Council and Executive Committee will be held April 24-28 in Fort Lauderdale, Fla.

The Executive Committee will lead off, gathering on April 24 and 25. Then the policy-making Council will meet on the 26th, 27th and 28th.

All sessions will be held at the Galt Hotel.

President Harry M. Cross will preside at both meetings.

## Council Extends Assignment of Recruiting Group

The special NCAA Committee on Recruiting, which saw a year's work culminated in passage of several pieces of its recommended legislation at the 1970 Convention, has been continued by the Council and asked to extend its efforts in that area.

Edwin H. Cady, Indiana University faculty representative, is chairman of the six-man group. Other members include John F. Bateman, head football coach, Rutgers University; John Dromo, head basketball coach, University of Louisville; Howard C. Gentry, director of athletics, Tennessee State University; Robert C. James, commissioner of the Mid-American Conference; and James D. Owens, head football coach, University of Washington.

Among items the Council asked the Committee to examine are means of limiting off-campus visits to prospects, additional ways in general of reducing pressures on the prospect and reducing recruiting costs.

Among the Committee's recom-

mendations approved in January were a limit of two paid visits by a prospect to an institution's campus; a ban on contacting a prospect at the site of his school's contests; and restrictions on the manner in which a prospect may be entertained during a visit to a member institution's campus.

## Football Rules Committee Makes 21 Changes in Rules

Twenty-one rules changes were made by the NCAA Football Rules Committee during its meeting in January, most of a minor nature. Significant changes were made involving the forward pass.

Five different changes were made to define the catch and possession of a legal forward pass. The receiver has to return to the ground in the field of play or end zone to have a completed forward pass, unless he is so held that the provisions of the dead ball rule apply. The catch of a lateral pass or fumble caught in the air is also included in this interpretation.

A change was made in the interference call. The defense now has to meet the same requirements as the offense on pass interference. In both cases, any foul which occurs to an eligible receiver beyond the line of scrimmage during a down in which a legal forward pass is thrown, will be pass interference.

This will eliminate the 15-yard penalty from the spot of the foul that was enforced under last year's rule. Such a penalty meant, on many occasions, in effect a 30- or 40-yard penalty.

The Committee is vitally concerned about knee injuries, and

wrote into the football code, under the coaching ethics section, a statement concerning blind-side and crack-back blocking.

### Cleat Shortened

In this regard, the permissible length of the cleat was shortened. The maximum length now will be 1/2 inch.

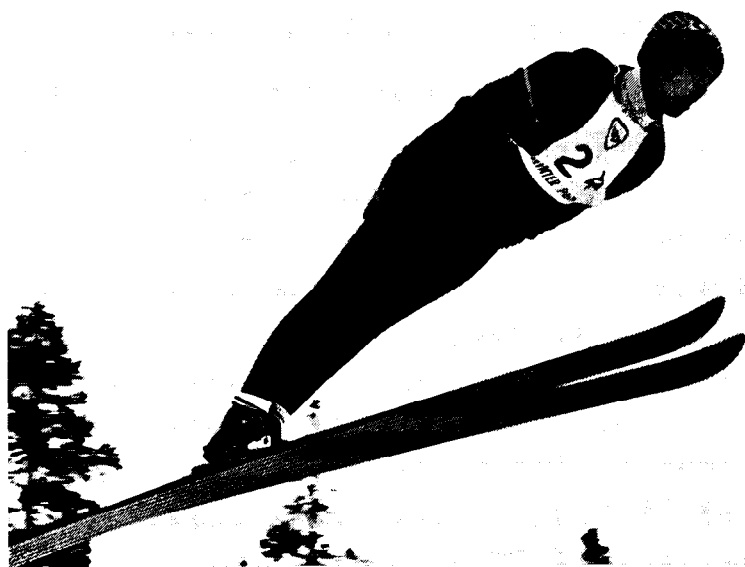
If the incidence of knee injuries continues to grow, despite such rules and cooperation of coaching techniques, the Committee feels a rule will be passed to prevent blocking below the waist in all except close line play.

The Committee also:

Made it illegal for a player to simulate a fair catch signal during a down in which a legal scrimmage kick was made, and provides for a clearer definition of extending the arm and hand clearly above the head on a fair catch signal;

Legalized insignias in the middle of the field provided the yard lines running through them are discernible to the officials and the players;

Limited the numbers to be used on jerseys to 1 to 99. The three-digit numbers allowed last year for the Centennial did not conform to size of legal numbers.



Typical of the 2500 student-athletes who will be competing in NCAA National Championship events this month is Odd Hammernes of Denver University. The NCAA sponsors 12 Championships within a month. Hammernes is the defending Jumping champion in the National Collegiate Skiing Championships, to be held March 5-7 at Franconia, N. H. The event will be hosted by Dartmouth.

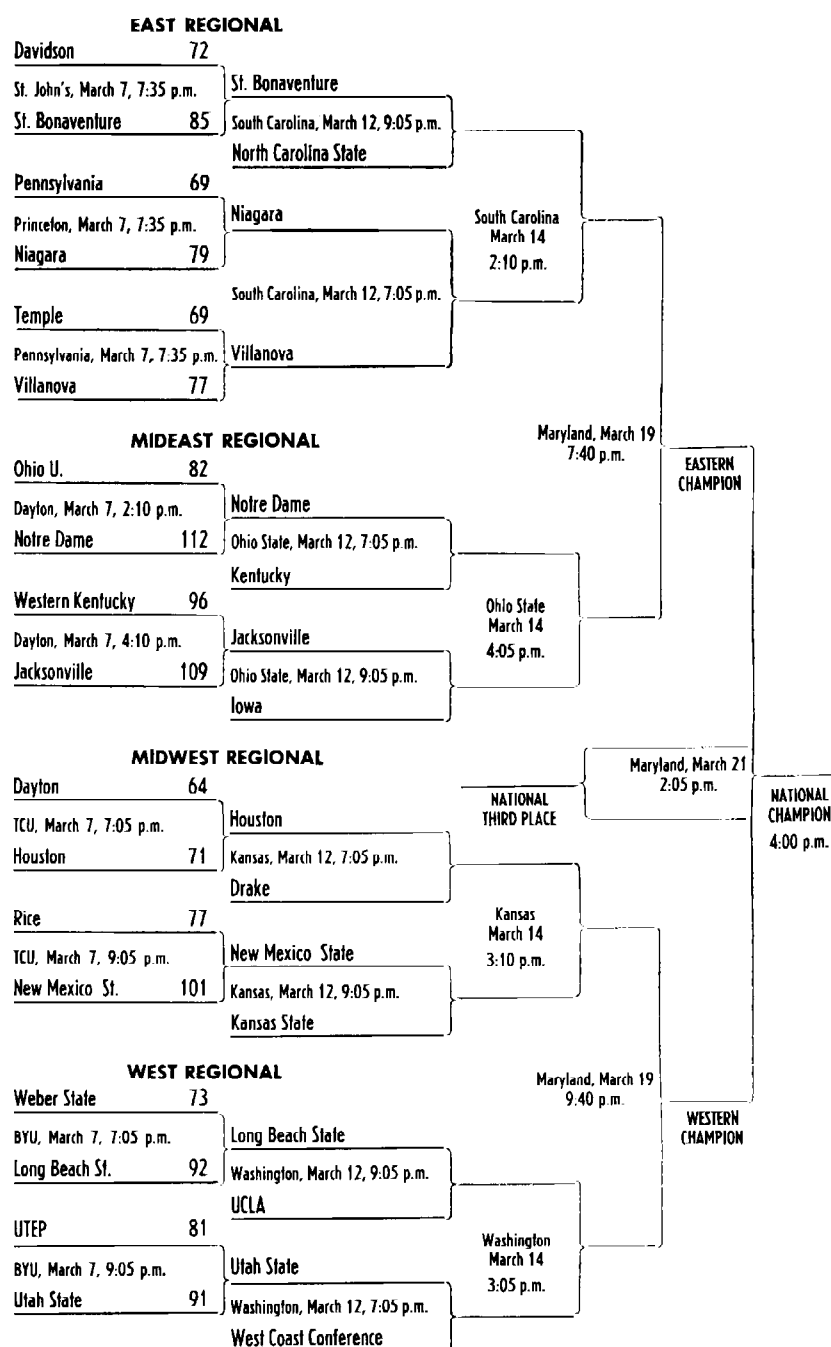

## NOTES and QUOTES

**Russ Fortier** has been named head football coach at Moorhead State College. Fortier, a former assistant at Moorhead, replaces Dwaine Hoberg who has resigned after 10 years as head coach. Fortier is a graduate of North Dakota State University, and co-captained the football team there in 1959.

**Bobby Richardson** will be the head baseball coach at the University of South Carolina. The former New York Yankee great is a South Carolina native.

**Jack Gregory** has been appointed head football coach at the University of Rhode Island. Gregory was formerly head coach at Villanova.

**Wayne Hardin** has been appointed to the head football coaching job at Temple University. Hardin formerly coached at the U.S. Naval Academy. He succeeds George Makris, who resigned recently after 10 years at Temple.

**Otto Graham** has returned to the Coast Guard Academy. Graham was formerly head football coach and athletic director at the Academy. He left to become head coach of the Washington Redskins four years ago. He will return as director of athletics. Graham will not coach football.

**Bob DeMoss**, long time assistant football coach at Purdue, has been named head coach there, with the retirement of **Jack Mollenkopf**. Mollenkopf had spent 23 seasons coaching Purdue, while DeMoss has been on the staff since his graduation from Purdue in 1950. He twice served as acting coach when Mollenkopf was ill. Mollenkopf had reached Purdue's mandatory retirement age.

**George Clemens** has been appointed head baseball coach at the University of Rochester. Clemens also will serve as an assistant football coach. He has been coaching football at Harvard, Boston College and the University of Detroit.

**Jack Thurnblad**, basketball coach and chairman of the men's physical education department at Carleton College, has been appointed director of athletics. He will assume the position after the retirement of Melvin H. Taube in June. Taube will also retire as football coach, and that job will be taken over by **Dale Quist**, who has been coaching at Shattuck High School, Faribault, Minn.

**Bob Deming**, who led the State University of New York at Buffalo football team to a 6-3 as acting coach this past season, has been awarded a three-year contract as head coach. Deming has been an assistant coach at Buffalo for ten years. He is a graduate of Colgate.

The Rose Bowl was the 454th consecutive **Southern California** game attended by **Giles Pellerin** of Los Angeles, both home and away, since his student days at USC in 1926. The 62-year-old accounting examiner and one-man travel bureau has traveled some 68,000 miles to see all 17 USC-Notre Dame games played in South Bend. He's watched USC in Chicago's Soldier Field, New York's Yankee Stadium, and many places in between.

Pellerin figures he's spent about \$16,000 on football trips in 43 years, "but I could have spent a lot more money on other things." Pellerin kept his streak going despite an appendectomy in 1949 and stomach surgery last summer. He's determined to go on: "I'm shooting for 500 in a row (sometime in 1974), then I'll go longer if possible."

**Samuel P. Saucedo**, a faculty member and former Marquette athlete, has been named director of athletics at Marquette. Saucedo is a former chairman of the Marquette athletic board and is now professor of modern languages. He will take office January 1. He succeeds Stanley Lowe, who died in August.

**John Jardine** is the new head football coach at Wisconsin. Jardine has been the top assistant at UCLA. He succeeds John Coatta. Jardine's brother Len is head coach at Brown. Both Jardine brothers played at Purdue.

**Cecil "Hootie" Ingram**, defensive coach at Arkansas, is the new head football coach at Clemson. He replaces Frank Howard, who will remain as director of athletics at Clemson. Howard was the dean of Atlantic Coast Conference coaches, having been at Clemson for 30 years. Ingram has been at Arkansas since the 1967 season.

The **Big Sky Conference** membership has been expanded by two institutions. Boise State College and Northern Arizona join Montana, Idaho, Montana State, Idaho State, Gonzaga and Weber State in the Conference.

For **Navy's Midshipmen**, it wasn't how they played the game recently, but whether they found a place to play. Incredibly, the Middies played their first four "home" games on four different courts. Because of delays in installing a synthetic surface in Navy Fieldhouse, they first moved to Dahlgren Hall. The second game at Dahlgren was rained out when its 60-year-old roof leaked. That game was moved to a gym down the street. If that wasn't enough, the next game was moved to Georgetown because of a conflicting function at Dahlgren. Finally, the Middies occupied their renovated fieldhouse for the Princeton game.

# 10 Basketball All-Star Games Certified For 1970 by NCAA

Ten senior basketball all-star games have been certified for 1970 by the NCAA Extra Events Committee.

Such certification signals that the game meets the requirements of NCAA Bylaw 7A-2-(d), and will not deprive the participant of remaining eligibility in other intercollegiate sports.

The Committee also called the attention of member institutions to two new Constitutional provisions and a new Recommended Policy concerning all-star games, all passed by the 1970 Convention and effective as of Feb. 1.

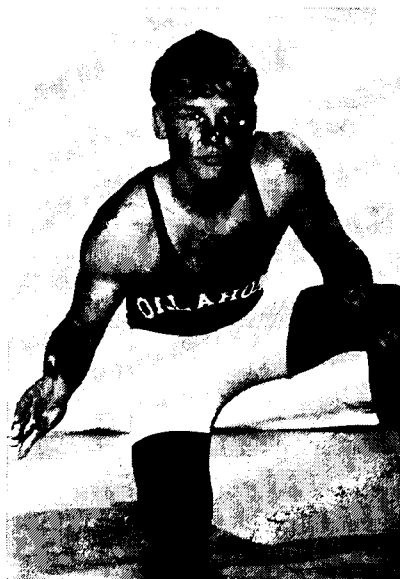
One provision stipulates that staff members shall not participate in any capacity in an uncertified all-star game. The second denies the student-athlete further eligibility in all sports if he participates in an uncertified contest.

The Recommended Policy urges member institutions to deny use of facilities for uncertified games.

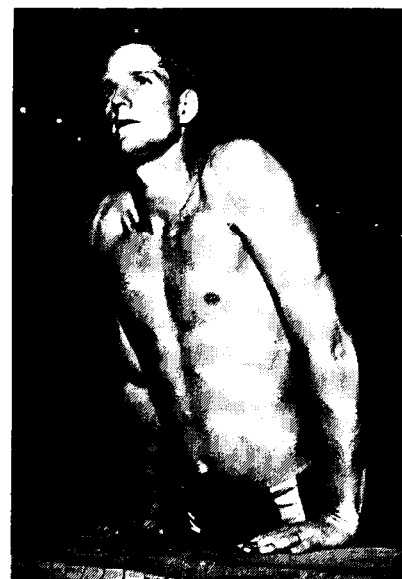

# Winter Sports Stars Prepare For NCAA Championship Events



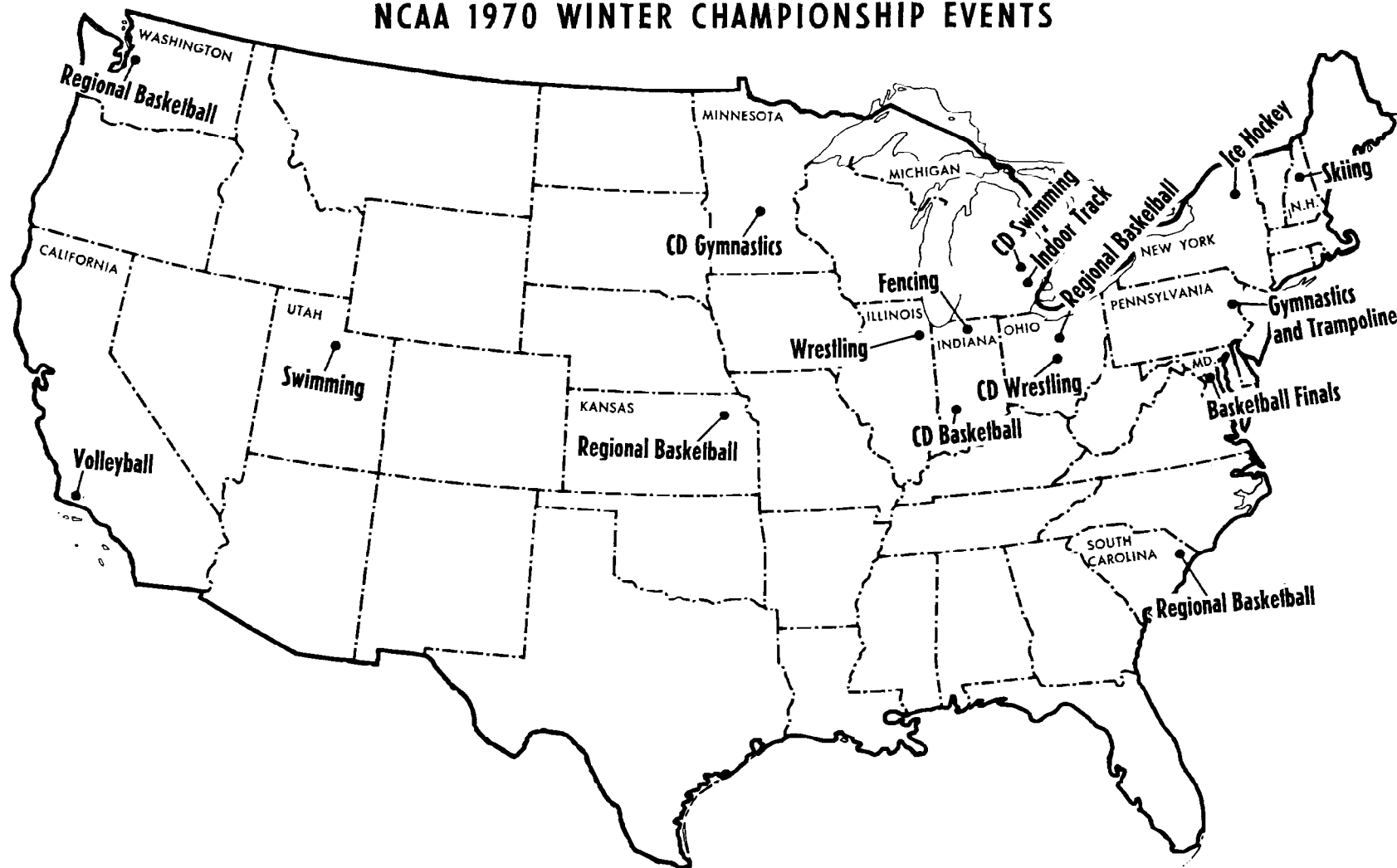
Mike Grant of Oklahoma will be returning to the National Collegiate Wrestling Championships after winning the 145-pound title in 1969.

## Council Approves Sample Financial Aid Form

A sample financial aid form for use by a member institution in confirming aid to a prospective student-athlete has been approved by the NCAA Council.

In approving the form, printed in this month's NEWS, the Council emphasized that it is not a mandatory instrument, but rather is a suggested form which is being made

available as a service and a guide.

The form meets the requirements of NCAA Constitution 3-4-(c), "Principles Governing Financial Aid," which specifies the institutional agency making the award shall provide the recipient a written statement of the amount, duration, conditions and terms thereof.

The Council acknowledged that

many members will wish to institutionalize aid forms, and will be required by local practices and policies to alter certain portions of the suggested form.

However, general adherence to this type of form will assure more complete compliance with Association legislation, the Council declared.

# CD Cage Tourney Attracts 32 Teams

Thirty-two teams will play in College Division regional basketball tournaments March 5-7 for the eight spots in the finals of the 14th annual tournament.

The finals will be held in Evansville's Roberts Stadium, March 11-13.

All four semifinalists from the 1969 tourney were named to the field this year. Defending champion Kentucky Wesleyan, titlist in three of the past four years, will host the South regional; American International will compete in the New England regional; Ashland has been selected for the Mideast; and Southwest Missouri was named to the Midwest.

The championship game will be

nationally televised by Global Sports on Friday, March 13. Game-time is 9:07 p.m. CST.

### SUMMARY OF PRINCIPAL TERMS AND CONDITIONS

1. The award must conform to the legislation of the institution, its conference (if any) and the NCAA.
2. Financial aid may be awarded for any term or session during which the student-athlete is in attendance as a regularly enrolled undergraduate. The renewal of a scholarship or grant-in-aid award shall be made on or before July 1 prior to the academic year it is to be effective.
3. Maximum permissible financial aid may not exceed "commonly accepted educational expenses"; i.e., tuition and fees, room and board, required course related supplies, books and an incidental expense allowance not to exceed \$15 per month or the financial limitations established by a conference or institution, if less.
4. A student-athlete may not receive financial assistance other than that administered by the institution except that financial assistance may be received from anyone upon whom the student-athlete is naturally or legally dependent. (There is a special provision concerning financial aid awarded on bases having no relationship whatsoever to the recipient's athletic ability.)
5. When unearned financial aid is awarded to a student and athletic ability is taken into consideration in making the award, such aid combined with other aid the student-athlete may receive from employment during semester or term time, other scholarships and grants-in-aid (including governmental grants for educational purposes) and like sources, may not exceed commonly accepted educational expenses as defined in paragraph 3 above. NCAA legislation permits limited exceptions to this requirement, most of which are related to military service benefits.

#### Institutional aid MAY NOT BE GRADATED OR TERMINATED during the period of its award:

1. Because of the recipient's athletic ability or his contribution to a team's success.
2. Because an injury prevents the recipient from participating in athletics.

#### Institutional aid MAY BE GRADATED OR TERMINATED during the period of its award if the recipient:

1. Does not satisfy the stated institutional academic requirements for like scholarships or grants-in-aid.
2. Voluntarily renders himself ineligible for intercollegiate athletic competition.
3. Fraudulently misrepresents any information on his application, letter-of-intent or tender.
4. Engages in serious misconduct warranting substantial disciplinary penalty by the appropriate institutional committee or agency. (Serious misconduct means conduct of sufficient gravity that if comparable conduct occurred in other departments of the institution, similar substantial disciplinary penalty could properly be imposed. Serious misconduct includes manifest disobedience through violation of institutional regulations or established athletic department policies and rules applicable to all student-athletes.)

Such **GRADATION OR TERMINATION** of an award may occur if:

1. The action is taken by the institution's regular disciplinary and/or awards authority.
2. The student-athlete has had opportunity for a hearing.
3. The action is based on institutional policy applicable to the general student body.

## ACC's Jim Weaver Active Leader

James H. (Jim) Weaver, for 17 years athletic director at Wake Forest College, was chosen commissioner of the Atlantic Coast Conference when it was founded in June of 1954.

Now one of intercollegiate athletics' most active leaders, he is a member of the NCAA Executive Committee and is serving his second term as chairman of the Collegiate Commissioners Association. He is immediate past chairman of the NCAA Academic Testing and Requirements Committee.

Weaver began his athletic career at Emory and Henry in 1919 where he played football, basketball and baseball. His father, Dr. Charles C. Weaver, a Methodist minister, was president of the college at that time.

After a short stay at Duke, Weaver transferred to Centenary College in Shreveport, La., where he played football under the late Alvin (Bo) McMillan from 1922 through 1924, earning All-State honors as an end in both 1923 and 1924.

### Frosh Football Coach

After earning his BS degree in biology in 1925, he remained at Centenary as freshman football coach until he was appointed head coach at Nacogdoches, Texas, High School. He returned to North Carolina in 1928 to coach at Oak Ridge Institute. He also taught history, geometry and biology.

He remained at Oak Ridge until 1933 when he resigned to become head football coach at Wake Forest. During his stay at Oak Ridge he also umpired baseball professionally.

In the spring of 1937 Weaver was named athletic director at Wake Forest and D. C. (Peahead) Walker assumed the duties of head coach. He directed the athletic fortunes of the Deacons for 17 years until he was named commissioner of the ACC.

While serving as athletic director, he also was coach of the golf team and was responsible for Arnold Palmer becoming a Wake Forest letterman.

Andy Everest, long time aid to Jack Curtice, has taken over the head football coaching chores from Curtice at the University of California, Santa Barbara. Curtice has retired from coaching after 40 years, but will remain as director of athletics at Santa Barbara. Everest starred for Curtice at Texas Western.

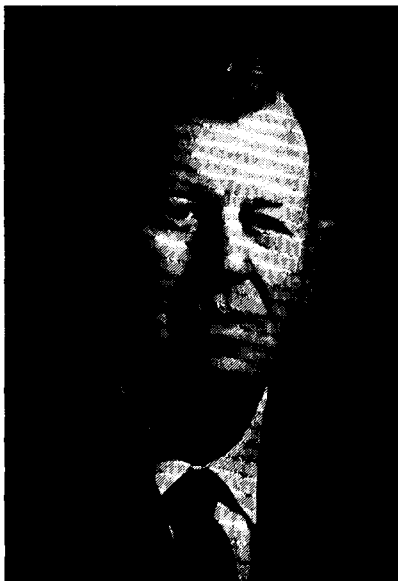

## Diamond Coaches Warned On Royals' School

A warning to coaches and players concerning the planned Kansas City Royals Baseball Academy has been sounded by the NCAA Eligibility Committee.

It pointed out that participation in the Academy, or tryouts for the Academy for which expenses are paid, renders any young man permanently ineligible for intercollegiate competition in all sports as NCAA members.

The Academy apparently is an attempt by the expansion team to glean a few prospects from youngsters who have not had an extensive baseball experience, but who may have natural physical ability. The Royals plan an intensive schooling experience for each enrollee.

Meanwhile, all those tried out will be made ineligible for college athletics because the club will pay travel expenses and living expenses while the prospect is at the Academy.

Such payment is specifically prohibited by O.I. 11 of Article 3, Section 1 of the NCAA Constitution, the Committee pointed out.

## CD Basketball Title Game on National TV

The championship game of the National College Division Basketball Championship will be nationally televised by the Global Sports Television Network of Palo Alto, Calif.

The championship game will be played Friday night, March 13, in Evansville, Ind. Evansville will be blacked out in conformance with the NCAA's basketball television policy.

It will make the first national television exposure for the 13-year old tournament which has been shown both live and delayed on a regional basis in the past.

Thirty-two teams will be selected to play in eight regional tournaments on March 6-7 with the winners advancing to the finals in Evansville beginning March 11.

The championship game is scheduled for 9:07 p.m. (CST).
